

#### Problems and predicaments

#### The Great Acceleration

- 19. **Soil degradation:** Intensive and mechanized agriculture destroys in decades soil structure that has taken millennia to create.

#### Solutions – Great Acceleration

#### Population growth

## Personal carbon dioxide emission rationing

The exact value for personal carbon dioxide emissions that would keep global warming under 1.5 degrees Celsius is complex to estimate and varies depending on many factors. However, to give a ballpark figure, let's use the global carbon budget.

The Intergovernmental Panel on Climate Change (IPCC) in their 2018 special report estimated that the remaining carbon budget to keep warming under 1.5 degrees Celsius with a 66% chance was about 420 gigatons of CO2 at the start of 2018.

Considering that the world population is around 7.8 billion as of 2020 and is expected to reach 8.5 billion by 2030, let's use an average of about 8.15 billion people.

If we were to divide the 420 gigatons of CO2 by 8.15 billion people, we'd get roughly 51.5 tons of CO2 per person from 2018 onwards.

However, it's also important to note that global emissions are currently about 42 gigatons per year (as of 2020). At this rate, the carbon budget for 1.5 degrees Celsius would be used up in about 10 years.

These figures should only be used as a rough estimate because they do not take into account many other factors, such as the fact that some level of carbon emissions is almost unavoidable in our current society, the different emission levels between countries and individuals, and the impact of other greenhouse gases.

So in an equal world scenario, if everyone was assigned an equal share of the remaining carbon budget, the amount would be quite low and would require drastic changes in our lifestyles and energy systems to achieve. This emphasizes the urgency of taking action on climate change.

The annual per person carbon dioxide emissions allowance can be calculated by taking the overall personal allowance and dividing it by the number of years.

We had an estimated 51.5 tons (or 51,500 kilograms) of CO2 per person from 2018 onwards to stay below 1.5 degrees Celsius of warming. If we were to divide this by, say, 10 years (considering the urgency of climate change and the rapid depletion of the carbon budget), we'd get roughly 5,150 kilograms (or 5.15 tons) of CO2 per person per year.

However, this calculation is a very simplified version of a much more complex problem. It doesn't take into account a range of factors such as:

- 1. The global carbon budget is being rapidly depleted, and at current rates of emissions, the budget for 1.5 degrees Celsius would be used up in less than 10 years.
- 2. There's a significant variation in per-capita emissions among different countries. For instance, the average American has a much larger carbon footprint than the average resident of a developing country.
